Abstract Taking an historical approach, and drawing on developments and case studies from both Cold War Germanys as well as the Berlin Republic, this workshop is dedicated to understanding the historical development better, but also the ramifications and contradictions of Germany's purported role as a "Green Superpower." It intends to explore the realities of German environmental engagement, but also to analyze the ways in which this engagement has been perceived, focusing on how Germany's green reputation evolved over the past half-century and looking into how and why it has deteriorated over the past decade.
